We Did It!

A CLEAR: A person at willing and knowing cause over his own life, his body and his surroundings and without a reactive or subconscious mind.

In the 19th ACC there were 35 students. During this course 15 of these students attained the state of Clear. Several others remained to co-audit at course-end and will probably reach Clear.

The 19th Advanced Clinical Course began January 6, 1958. It ended February 14, 1958. The first two weeks of the course were devoted to a course in communication and indoctrination in order to smooth out the student auditing. These first two weeks were double-timed, which is to say they represented four weeks of training in terms of class hours.

The remaining four weeks were devoted to co-auditing. In each week half the class audited the other half, which means that each student, in the four auditing weeks gave two weeks and received two weeks of auditing.

A total of 72 hours of student auditing was therefore received by each student.

I was extremely careful not to coach the actual auditing and gave the course lectures. The coaching was done by LRH Jr., Dr. Richard Halpern and Dr. Jan Halpern. I refrained from actual coaching so that the results were, in effect, created by the instructors. Thus, somebody else has not only made a clear, but 15 people or more have made clears in just this one course.

VALIDATION

Before an auditor can hope to clear anyone he should be at the level of Validated HCA. Contact a nearby ACC graduate or office or come to Washington. Your certificate needs its stamp. You need a modern look at it. The HCO Board of Review will help you get that stamp.

These, of course, were splendid students, long-time Scientologists. But it has long been a maxim that the hardest person to process is the old-time Scientologist. This was perhaps the case yesterday. It is not the case today, since my development of HGC Procedure of February 6, 1958.

More students would have been clear in the course if I had earlier developed a special method of reducing "fields" (the black curtains some people have). A development I released toward the end of the fifth week on this took care of the problem but several members of the course were not again audited.

The fifteen who did reach Clear in the course have been granted the right to wear Clear Bracelets.

At least five more course members, on continued co-auditing at the course conclusion probably have reached Clear but have not been tested at this writing.

Unlike early Clears, who had no idea of the subject of Dianetics or Scientology and no goals for auditing, all modern Clears to date have shown a strong desire to continue with Scientology in a much more active role even when they were not at first auditors. The modern Clear has ambitions for Scientology.

It was born out that there is an exact test for Clears and although there are higher states than Clear, the state of Clear itself is definite and not comparative as some people have believed.

The E-meter on a Clear reads only body resistance and registers only body functions such as heart beat, breathing and the effort to talk. A Clear can, however, make a mockup react upon the body more or less at will. Contrary to early belief, a Clear's body is not off the top of a meter. A Clear's body registers a more or less exact number of ohms of resistance. The body is not the person.

The Advanced Clinical Courses which are taught by myself require, in an applicant, the certification of HCA or HAA plus experience in auditing. Therefore this was a selected group--but a group more difficult in some ways than the ordinary preclear. Thus, this did not serve as a time estimate that could be generally applied to preclears.

However, the special character of the group is demonstrated to be no index of the feasibility of clearing. On preclears who had no training in Scientology and no wish to be audited initially, clearing has been indicated as relatively simple. Original desire to be cleared is not even a necessity in clearing today.

Subject: Answering your query on current Academy curriculum.

The purpose of the HCA course is to create the best auditors in the world. Therefore, a graduating HCA should have:

- (1) A competent grasp of all TRs-- 0 - 10.
- (2) The ability to use the processes he is taught.
- (3) Enough theory to understand the processes he is taught and to assimilate further processes.
- (4) The ability and willingness to cope with the 4 divisions of life.
- (5) A high degree of willingness to help another person get better.
- (6) Enough data and practice to be able to audit groups, render assists, do individual processing toward goals other than clearing, to be able to process individuals toward clear, to be able to handle emergency situations and to handle their own lives better than prior to the course.

Therefore, we teach:

- (1) Five levels of Indoctrination. This includes TRs 0 thru 9.
- (2) The 4 divisions of life.
- (3) The Six Basic Process Types and the current most workable examples of each.
- (4) The theory of: ARC, GAMES, Reality Scale, control, communication, havingness, effect scale, help & responsibility.
- (5) The theory of raising an individual on the tone scale by handling both thinkingness and mass.
- (6) The beingness of an auditor and the basic idea of auditing which is reversing the cycle of action of the MEST universe and is also the action of increasing ability rather than repairing wrongnesses.

Upper Courses

I recommend that all students, upon graduating should get some field experience, then return for special training in clearing people and in re-experiencing the TRs. A 5-week course as HAA. The TRs should be experienced from time to time in any case where the auditor is not yet clear enough to keep from putting processes on automatic. I recommend that training publicity should carry in it the idea that training alone or experience alone is not sufficient. Further, that one must be grounded in theory and practice of Scientology in general before he attempts clearing anyone. Ron has okayed this schedule.

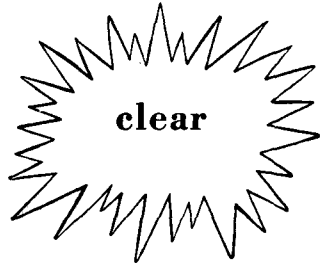
